

DIRECT DEBIT INSTRUCTION

- We encourage all teachers, student teachers and long-time members to subscribe to BWY via Direct Debit instruction. This saves time and effort for both parties.
- The Direct Debit Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the scheme is monitored and protected by your own Bank or Building Society.
- If the amounts to be paid or the payment dates change, you will be told of this in advance by at least 14 days or as agreed.
- If an error is made by The British Wheel of Yoga or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch of the amount paid.
- You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy to The British Wheel of Yoga.
- Members are responsible for cancelling a previous Standing Order or Direct Debit with their Bank or Building Society. The BWY reserves the right to consider any non-cancelled Standing Order/Direct Debit or any other over-payment as a donation.

INSURANCE

- Non-teaching members (aged 70 and under) of The British Wheel of Yoga receive Personal Accident and Civil Liability insurance cover. BWY teachers (including students) in the UK and Eire are covered by the above and by Instructor Indemnity.
- Every teacher must have BWY insurance. Each teacher in a family must pay the full membership rate as this includes specific insurance for teachers. Members aged over 70 years pay £1 less on all annual rates.
- If you are a UK resident, ticking the Gift Aid Declaration gives a considerable benefit to BWY at no extra cost to you. From every £100 that is 'Gift Aided'; we recover an extra £25.00 from the Taxman.
- If you pay higher tax (at 40%), BWY can claim an even higher rate relief. Non taxpayers are not able to take out a Gift Aid Declaration.
- The Gift Aid declaration will continue until cancelled by you. You can cancel your Gift Aid Declaration at any time by contacting BWY Central Office.

REPS

- REPs (Register of Exercise Professionals) The BWY is able to offer REPs membership to its qualified teachers at the discounted rate of £8 per annum. This membership is for a full or part year, renewable on 1st November each year.
