Hold a current CRB Enhanced Disclosure (renewal required 3 years from date of issue)	Yes – through BWY, if teaching privately Yes – through your employer/contractor, if not teaching privately	Yes, if parent is NOT present – see note below “Adult Classes with Under 18s”
Complete additional BWY paperwork in accordance with CP Policy	Yes	Not necessary
