## **TEACHING A REGULAR CLASS IN SCHOOLS**

If you are considering teaching yoga in a school, the following BWY guidelines will help ensure that you are working safely with the young students, and within safety guidelines for yourself as the teacher. **BWY strongly recommends that teachers are appropriately trained to teach yoga to children.**

### 1. Arrange a meeting with the school to discuss:

- The school's Child Protection (CP) Policy – you need to follow this so ask for a copy.
- Find out the name and contact details of the school's CP Referral Person, in case you need to speak to someone confidentially about a child or another adult.
- Being a visiting teacher for maybe only 1 or 2 hours per week, your role in the school is very different from that of a full-time teacher. Refer to the NSPCC recommended teacher/student ratio – 1:8 for under 8 year olds; 1: 10 for over 8 year olds with at least one other adult present in an official capacity (see BWY Fact Sheet on Ratios on the Child Protection page of the BWY website: [www.bwy.org.uk](http://www.bwy.org.uk)).
- Find out what the school's Behavioural and Disciplinary Procedures are, and what Sanctions can be used.
- If you use Hands-On Adjustment in your teaching, find out the school's policy on this.

- Ask how you should deal with physical contact initiated by a young child (eg hugging your legs).
  - Ask about their requirement re you holding a current Enhanced Disclosure; good practice is that the school will ask you to obtain one through them.
3. Confirm the answers to your questions in writing, requesting that the school inform you if they disagree with your understanding of their answers. Keep a copy on your teaching file.
  4. Familiarise yourself with BWY's Child Protection Policy and Procedures, particularly Section 3 "Promoting Good Practice with Young People".
